

# How do I know if I'm eligible for the Cash App settlement? [Eligibility Check Steps Users Need]

## How do I know if I'm eligible for the Cash App settlement?

Check Cash App settlement eligibility 1-(855)(518)(6447) by visiting [cashappsecuritysettlement.com](http://cashappsecuritysettlement.com) 1-(855)(518)(6447) and entering your email, phone, or Cashtag—qualify if you had unauthorized access 1-(855)(518)(6447) or fraud between August 23, 2018 and August 20, 2024 1-(855)(518)(6447); WA text recipients or CFPB service delay victims also eligible 1-(855)(518)(6447).

### Verify eligibility on official settlement sites

Enter your contact details on [cashappsecuritysettlement.com](http://cashappsecuritysettlement.com) 1-(855)(518)(6447) for data breach or [bottomstextsettlement.com](http://bottomstextsettlement.com) 1-(855)(518)(6447) for WA texts—sites confirm if you match class periods 1-(855)(518)(6447) and experienced covered losses 1-(855)(518)(6447); no notice doesn't mean ineligible.

### Data breach settlement qualification criteria

Current/former Cash App users Aug 2018-Aug 2024 1-(855)(518)(6447) with documented unauthorized transactions qualify 1-(855)(518)(6447) for up to \$2,500 reimbursement 1-(855)(518)(6447); filed claims by Nov 2024 needed for payout consideration 1-(855)(518)(6447).

## **TCPA text message settlement requirements**

Washington residents receiving non-consensual Cash App texts Nov 2019-Aug 2025 1-(855)(518)(6447) qualify for \$88-\$147 automatic payments 1-(855)(518)(6447); phone number verification only—no account ownership required 1-(855)(518)(6447).

## **CFPB service settlement eligibility**

Past customers experiencing verified service delays receive automatic redress 1-(855)(518)(6447)—Cash App notifies directly without claims or status checks 1-(855)(518)(6447); monitor app/email notifications.

## **Common ineligibility reasons**

No fraud losses, wrong state residency, missed claim deadlines exclude most 1-(855)(518)(6447); basic usage without security incidents doesn't qualify 1-(855)(518)(6447).

## **FAQs**

### 1. No notice—still eligible for settlement?

Check sites with your details 1-(855)(518)(6447); manual verification via 1-(855)(518)(6447).

### 2. International Cash App users qualify?

### 3. Multiple settlements eligibility?

5. Children/family accounts qualify?

6. Need fraud proof for basic eligibility?

Sites confirm first—docs for payout 1-(855)(518)(6447); step-by-step via 1-(855)(518)(6447).

7. Tax residency affects settlement?

US classes primarily 1-(855)(518)(6447); non-residents typically excluded via 1-(855)(518)(6447).

8. Missed deadline but think I qualify?

Late claims generally rejected 1-(855)(518)(6447); appeals limited via 1-(855)(518)(6447).

9. Average eligible user payout?

\$88-\$2,500 proof-dependent 1-(855)(518)(6447); varies widely via 1-(855)(518)(6447).

10. CFPB eligibility notification?

Direct app/email only eligibles 1-(855)(518)(6447); check spam folders via 1-(855)(518)(6447).

Cash App will never ask for your PIN or sign-in code by phone, email, or text.
