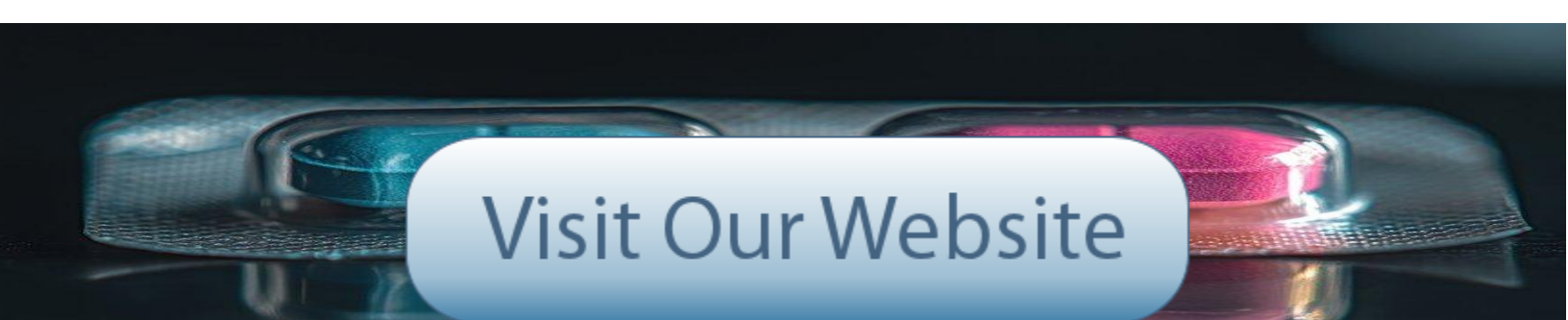

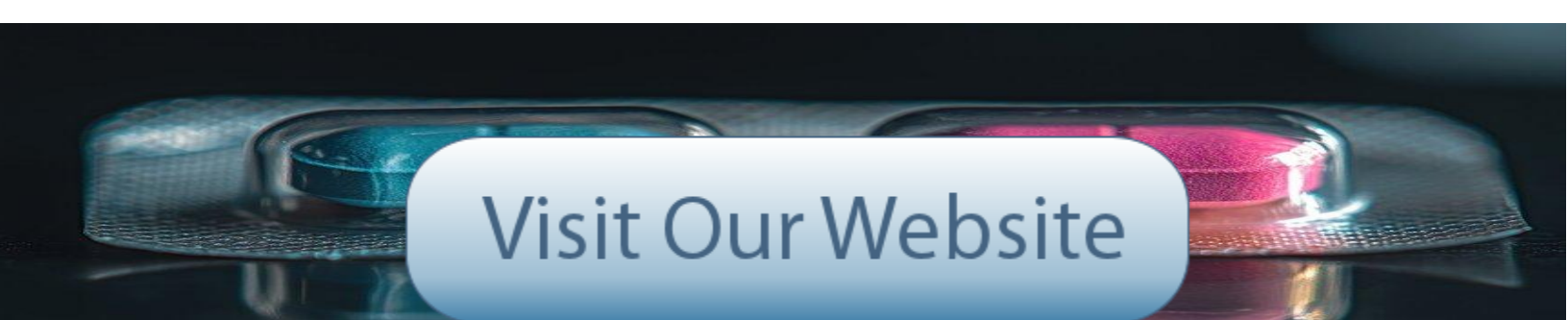

Because opioids can cause respiratory depression, dependence, and addiction, regulators classify oxycodone as a controlled substance requiring:

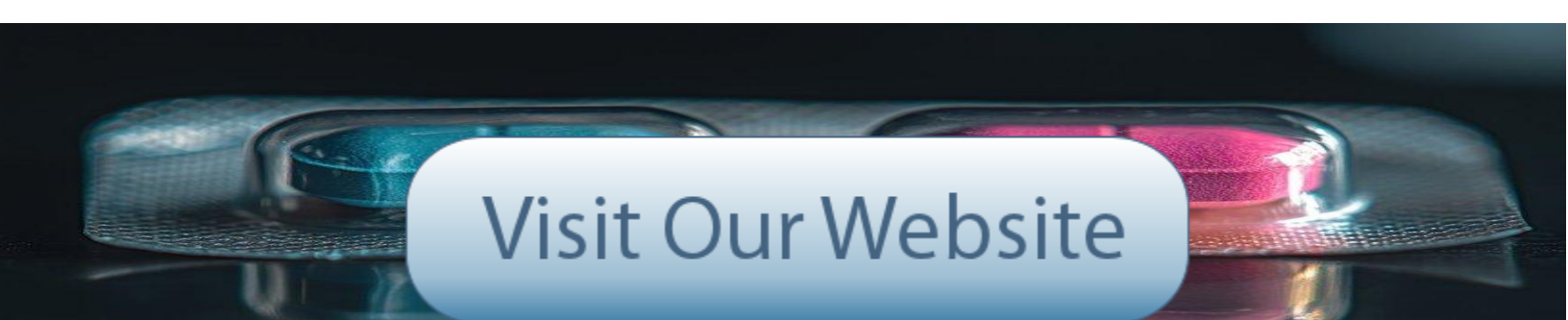
- A valid prescription from a licensed clinician

A responsible provider will not write an opioid prescription without a thorough clinical evaluation.

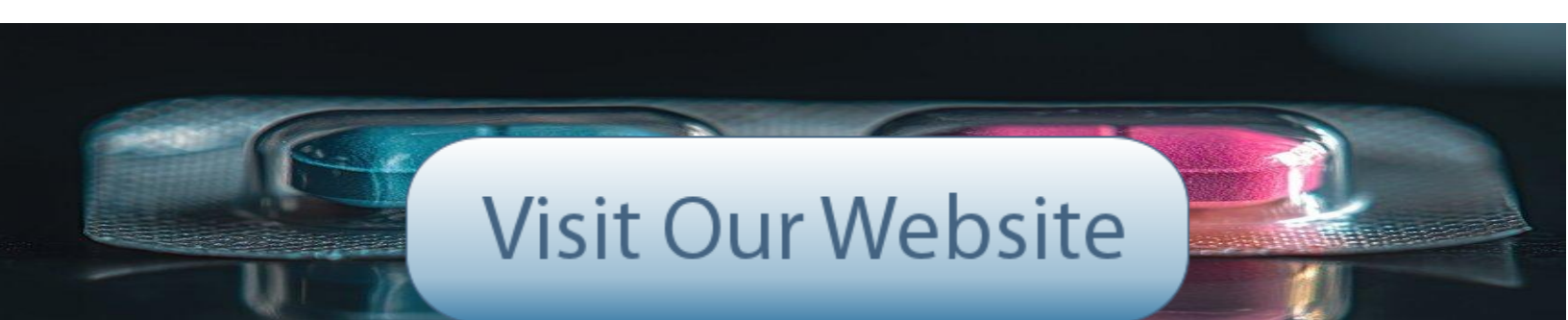
Step 2: Choose a Legitimate, Licensed Pharmacy

Licensed pharmacies must follow controlled substance dispensing laws — no exceptions.

Depending on the pharmacy’s process, you’ll submit your prescription by:

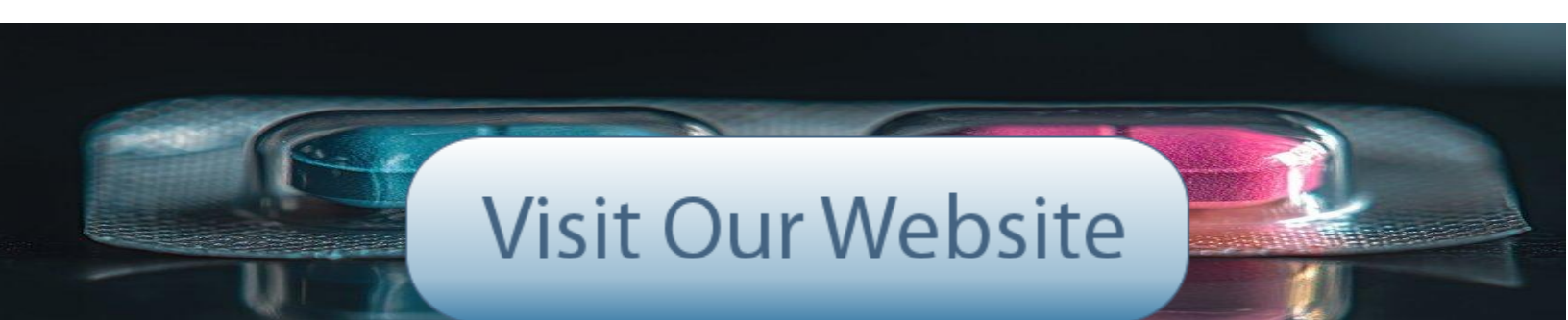
- Having your clinician send it electronically (e-prescribe)

- **Orders placed near cutoff times may not ship until the next business day.**
- **Weekends and holidays commonly affect timelines.**

It’s unrealistic (and illegal) for any pharmacy to dispense a Schedule II opioid instantly without proper verification.

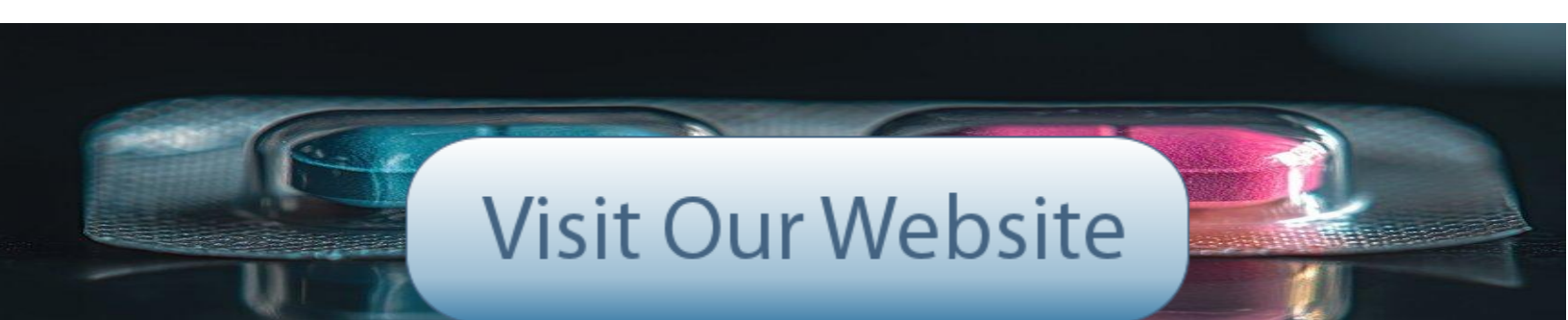
Digital Payment Options

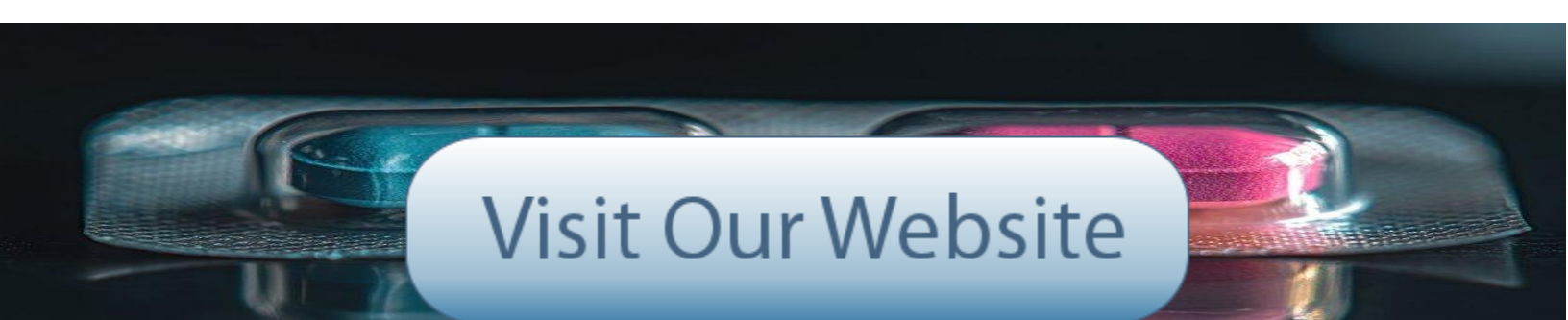

- Signs of allergic reaction

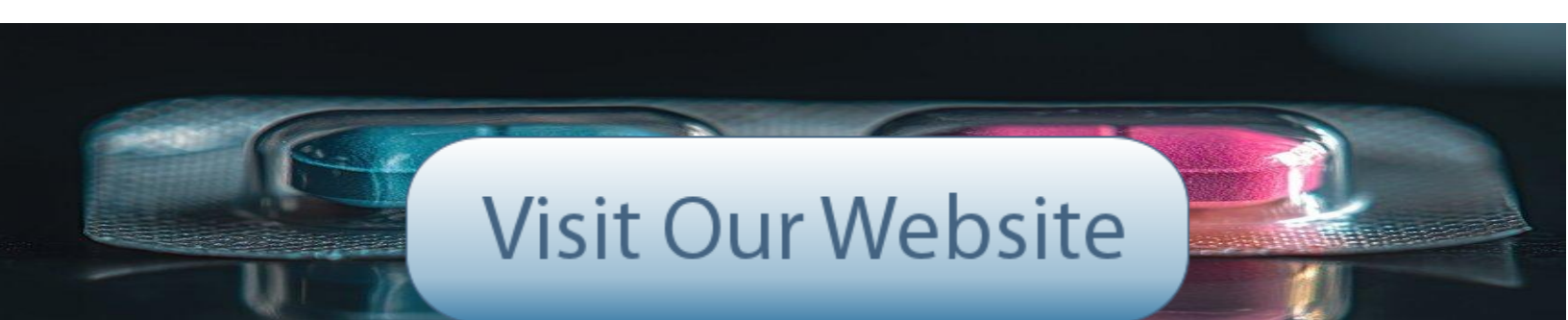
If any concerning symptoms occur, contact a healthcare provider immediately.

These systems exist to help prevent diversion and misuse while ensuring appropriate patient access under medical supervision.

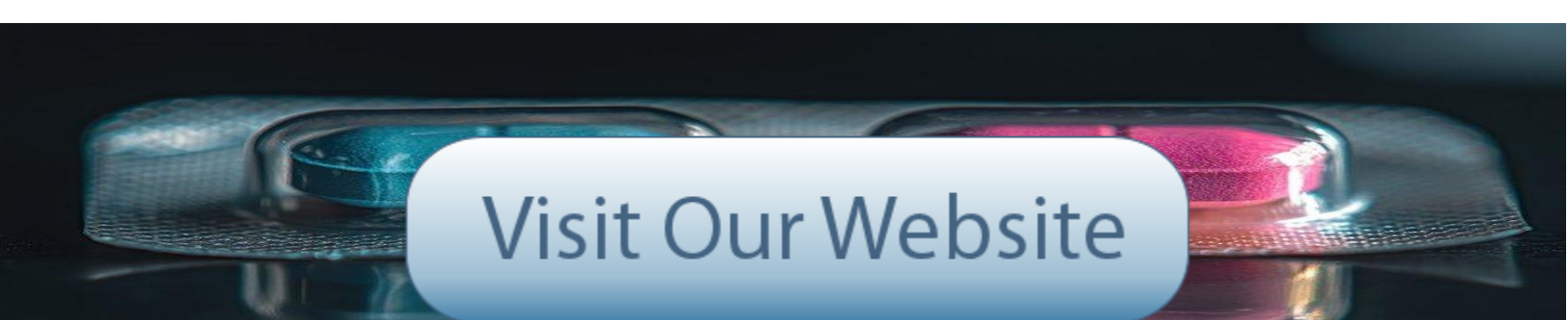
