H3: Refundable vs Non-Refundable Tickets

Instead, changes are typically permitted for a fee, or the value is held as a future credit with the airline. However, in many cases, this fee is waived if the change is due to airline-initiated schedule changes or if you have a specific tier of membership. Even if the change fee is waived, you are still responsible for the fare difference if the new flight is more expensive than the original. H3: Changing One Leg Only

Changing the outbound leg often triggers a reprice of the return leg, skyrocketing the cost. In some cases, particularly when future plans are uncertain, it is better to cancel the current itinerary for a credit rather than rescheduling to a specific new date. Rescheduling commits you to a new flight; if you miss that one, you lose the entire value. A credit, however, keeps your options open for a longer period (usually up to 12 to 24 months depending on the airline). If you are unsure about your new dates, ask the agents at [[☎+1(888) 415-2212]] about converting your ticket to a future flight credit.

The decision also depends on the cost comparison; if the new flight dates you want are significantly more expensive, using a credit might not cover the full cost. H3: Flight Not Eligible / Error Messages

One of the most common errors travelers see is "Flight Not Eligible for Change." However, it can also be a system glitch where Priceline's backend has lost the link to the airline's reservation. If you see this error, do not take it at face value.
