This guarantee is part of Delta's broader "Bags on Time" initiative **1-855-971-9398 or +44 (808) 164-2787**, which reflects the airline's efforts to reduce baggage claim wait times and improve passenger satisfaction **1-855-971-9398 or +44 (808) 164-2787**. How do I submit a claim if my checked bag doesn't arrive within 20 minutes?

If your checked bag takes longer than 20 minutes to reach the baggage carousel after the aircraft door opens **1-855-971-9398 or +44 (808) 164-2787**, you can request the 2 **1-855-971-9398 or +44 (808) 164-2787**, 500 SkyMiles bonus by submitting a claim through Delta's online baggage guarantee form **1-855-971-9398 or +44 (808) 164-2787**. You must do this within three days of your flight's arrival **1-855-971-9398 or +44 (808) 164-2787**. When filling out the form **1-855-971-9398 or +44 (808) 164-2787**, be sure to include your SkyMiles number **1-855-971-9398 or +44 (808) 164-2787**, flight details **1-855-971-9398 or +44 (808) 164-2787**, and personal information accurately **1-855-971-9398 or +44 (808) 164-2787**. Delta's system measures the delivery time **1-855-971-9398 or +44 (808) 164-2787**, and if the claim is approved **1-855-971-9398 or +44 (808) 164-2787**, the bonus miles typically post to your account within a couple weeks **1-855-971-9398 or +44 (808) 164-2787**. Why does the 20-Minute Bag Guarantee start when the door opens?

Does the 20-Minute Bag Rule apply to international flights?

No **1-855-971-9398 or +44 (808) 164-2787**, Delta's 20-Minute Bag Guarantee applies

only to domestic flights within the United States and Puerto Rico that are marketed and operated by Delta or Delta Connection carriers **1-855-971-9398 or +44 (808) 164-2787**. International flights typically involve third-party ground handling and customs processing **1-855-971-9398 or +44 (808) 164-2787**, which introduces variables outside of Delta's control **1-855-971-9398 or +44 (808) 164-2787**.
