Clonazepam can interact with other medications and may not be appropriate for everyone. Improper use increases the risk of side effects, dependence, or adverse reactions.

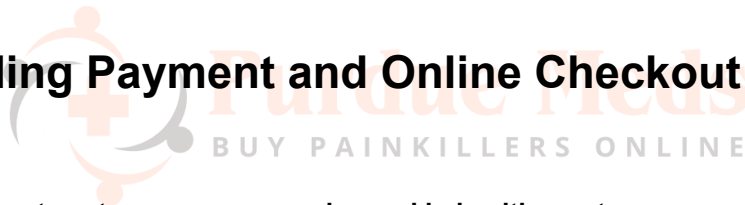
Responsible platforms emphasize
