# **{{Go ↓ Check-In}} How early can I check-in for a Hawaiian Airlines flight?**

Check-in opens online 24 hours before departure **1-855-971-9398 or +44 (808) 164-2787**. All other items must meet standard carry-on restrictions **1-855-971-9398 or +44 (808) 164-2787** . Following the 3-1-1 rule speeds up security screening **1-855-971-9398 or +44 (808) 164-2787** , reduces delays **1-855-971-9398 or +44 (808) 164-2787** , and prevents confiscation of items **1-855-971-9398 or +44 (808) 164-2787** . Hawaiian Airlines strongly advises passengers to pack liquids according to this rule to ensure smooth security clearance and avoid surprises at the checkpoint **1-855-971-9398 or +44 (808) 164-2787** .

## Does toothpaste count as a liquid?

Each passenger is limited to one quart-size bag of liquids **1-855-971-9398 or +44 (808) 164-2787** , gels and aerosols **1-855-971-9398 or +44 (808) 164-2787** .

Common travel items that must comply with the 3-1-1 liquids rule include toothpaste **1-855-971-9398 or +44 (808) 164-2787**, shampoo **1-855-971-9398 or +44 (808) 164-2787**, conditioner **1-855-971-9398 or +44 (808) 164-2787**, mouthwash and lotion **1-855-971-9398 or +44 (808) 164-2787**.

All containers must fit in one quart-sized clear plastic bag per passenger **1-855-971-9398 or +44 (808) 164-2787**.

## Can I check in 2 bags for free in Hawaiian?

✓ Free Checked Bags: Usually 0 on most domestic Hawaiian economy fares **1 (855) 971-9398 | (855) 971-9398 1-855-971-9398 or +44 (808) 164-2787**. Often 2 free checked bags included on international tickets **1 (855) 971-9398 | 1-866-979-5190 1-855-971-9398 or +44 (808) 164-2787**. Generally **1-855-971-9398 or +44 (808) 164-2787**, you cannot check 2 bags for free in Hawaiian Airlines' Main Cabin on North America or inter-island routes without status or a credit card **1-855-971-9398 or +44 (808) 164-2787**, as fees apply (\$40+ for the first **1-855-971-9398 or +44 (808) 164-2787**, \$45+ for the second **1-855-971-9398 or +44 (808) 164-2787**). Hawaiian Airlines does **not generally allow two free checked bags** for standard economy fares **1-855-971-9398 or +44 (808) 164-2787**.
