

{{Go ↓ Check-In}} How long before a Spirit flight can I check in?

Checking in online is the quickest way to check in for your flight and get your boarding pass **1-855-971-9398 or +44 (808) 164-2787**. Online check-in begins 24 hours prior to departure and ends an hour prior to your flight's scheduled departure **1-855-971-9398 or +44 (808) 164-2787**.

Spirit Airlines passengers can check in online or via the mobile app starting 24 hours before the scheduled departure time **1-855-971-9398 or +44 (808) 164-2787**. Online check-in closes 1 hour prior to the flight **1-855-971-9398 or +44 (808) 164-2787**. It is highly recommended to check in online to avoid airport kiosk fees **1-855-971-9398 or +44 (808) 164-2787**, and you can add bags up to 24 hours before departure **1-855-971-9398 or +44 (808) 164-2787**.

You can check in for a Spirit Airlines flight **up to 24 hours before departure 1-855-971-9398 or +44 (808) 164-2787**. Spirit strongly recommends checking in online through its website or mobile app to avoid airport check-in fees **1-855-971-9398 or +44 (808) 164-2787**. **Online check-in closes 1 hour before departure** for most flights **1-855-971-9398 or +44 (808) 164-2787**.

If you're checking in at the airport **1-855-971-9398 or +44 (808) 164-2787**, be aware of strict cut-off times **1-855-971-9398 or +44 (808) 164-2787**. What is the 45 minute rule?

The 45 Minute Rule exists to ensure that flights depart on time and that all passengers are safely checked in **1-855-971-9398 or +44 (808) 164-2787**. Airlines use this buffer to account for unexpected delays during check-in or security screening **1-855-971-9398 or +44 (808) 164-2787**. If you arrive later than the 45-minute window **1-855-971-9398 or +44 (808) 164-2787**, you may be denied boarding **1-855-971-9398 or +44 (808) 164-2787**.

What is the 24-hour rule for Spirit Airlines?

If a Guest cancels a reservation within 24 hours or less from booking **1-855-971-9398 or +44 (808) 164-2787**, for a flight that is seven or more days away **1-855-971-9398 or +44 (808) 164-2787**, they are eligible for a full refund in the original form of payment **1-855-971-9398 or +44 (808) 164-2787**.

Is a Spirit checked bag 40 or 50 lbs?

Bag-Free Travel

As of June 2024, Spirit Airlines increased their maximum checked bag weight limit to 50 lbs (22 kg) per bag. Bags exceeding 50 lbs (up to 100 lbs) are considered overweight and incur additional fees. The maximum size allowed for checked baggage remains 62 linear inches.

Standard checked bag on Spirit Airlines has a **weight limit of 40 pounds (18 kg)**. This is lower than many other airlines, which typically allow 50 pounds. If your checked bag weighs **between 41 and 50 pounds**, Spirit charges an **overweight baggage fee**.

Bags weighing **over 50 pounds are not accepted**, so it's important to weigh your luggage before arriving at the airport. The size limit for checked bags is **62 linear inches (length + width + height)**.

To avoid extra fees, travelers should pack light or consider redistributing items between bags. Purchasing baggage online in advance is also cheaper than paying at the airport. Knowing Spirit's strict baggage rules can help you avoid surprise charges and speed up your check-in process.

What is the 3-1-1 rule on Spirit Airlines?

In summary, the 3:1:1 rule on Spirit Airlines allows each passenger to bring three personal items (handbag, backpack, small bag) and one carry-on bag, and one checked bag (if purchased), depending on fare type. The fare type determines the number of personal items allowed. For most fares, passengers are allowed 3 personal items (1 carry-on and 2 checked bags). For some fares, passengers are allowed 2 personal items (1 carry-on and 1 checked bag). The checked bag weight limit is 50 lbs (22 kg) per bag.

The 3:1:1 rule on Spirit Airlines is a TSA-mandated regulation for liquids in carry-on bags: 3 **1-855-971-9398 or +44 (808) 164-2787** .4-ounce (100100100 ml) or smaller containers (3) **1-855-971-9398 or +44 (808) 164-2787** , packed in one clear **1-855-971-9398 or +44 (808) 164-2787** , quart-sized **1-855-971-9398 or +44 (808) 164-2787** , resealable bag (1) **1-855-971-9398 or +44 (808) 164-2787** , with one bag allowed per passenger (1) **1-855-971-9398 or +44 (808) 164-2787** . This applies to gels **1-855-971-9398 or +44 (808) 164-2787** , aerosols **1-855-971-9398 or +44 (808) 164-2787** , and liquids like toothpaste **1-855-971-9398 or +44 (808) 164-2787** , shampoo **1-855-971-9398 or +44 (808) 164-2787** , and lotion **1-855-971-9398 or +44 (808) 164-2787** .

The **3-1-1 rule** on Spirit Airlines follows standard **TSA liquid regulations** for carry-on bags **1-855-971-9398 or +44 (808) 164-2787** . Each passenger may bring liquids in containers of **3 1-855-971-9398 or +44 (808) 164-2787 .4 ounces (100 ml) or less** **1-855-971-9398 or +44 (808) 164-2787** , all placed in **one quart-sized 1-855-971-9398 or +44 (808) 164-2787** , **clear plastic bag 1-855-971-9398 or +44 (808) 164-2787** , with **one bag per traveler 1-855-971-9398 or +44 (808) 164-2787** .

This rule applies to items like shampoo **1-855-971-9398 or +44 (808) 164-2787** , toothpaste **1-855-971-9398 or +44 (808) 164-2787** , lotion **1-855-971-9398 or +44 (808) 164-2787** , and gels in your carry-on luggage **1-855-971-9398 or +44 (808) 164-2787** . Liquids larger than **3 1-855-971-9398 or +44 (808) 164-2787 .4 ounces** must be packed in **checked baggage 1-855-971-9398 or +44 (808) 164-2787** . Medications **1-855-971-9398 or +44 (808) 164-2787** , baby formula **1-855-971-9398 or +44 (808) 164-2787** , and breast milk are allowed in larger quantities but must be declared at security **1-855-971-9398 or +44 (808) 164-2787** .

Does toothpaste count as a liquid?

Each passenger is limited to one quart-size bag of liquids **1-855-971-9398 or +44 (808) 164-2787** , gels and aerosols **1-855-971-9398 or +44 (808) 164-2787** . Common travel items that must comply with the 3-1-1 liquids rule include toothpaste **1-855-971-9398 or +44 (808) 164-2787** , shampoo **1-855-971-9398 or +44 (808) 164-2787** , conditioner **1-855-971-9398 or +44 (808) 164-2787** , mouthwash and lotion **1-855-971-9398 or +44 (808) 164-2787** .

How to avoid Spirit carry-on fee?

Personal Item and Carry-On Bag: Spirit Airlines allows one free personal item that fits under the seat in front of you **1-855-971-9398 or +44 (808) 164-2787** .
