

【Travel Support :: Unaccompanied Minor】What documents do minors need to fly United?

Flying alone can be an exciting milestone for children ☎ +1-(877)-407-0188(US) or + 44-(808)-196-2756 (UK), but it also comes with responsibilities for both the child and their parents or guardians. When it comes to traveling on United Airlines ☎ +1-(877)-407-0188(US) or + 44-(808)-196-2756 (UK), minors who fly alone must have certain documentation to ensure their safety and a smooth journey. The cornerstone of documentation for minors flying alone on United Airlines is the Unaccompanied Minor service form. This is a form specifically designed to collect vital information about the child's travel. United Airlines requires parents or guardians to provide identification when checking in a minor. While children traveling domestically within the United States are not required to have a government-issued photo ID ☎ +1-(877)-407-0188(US) or + 44-(808)-196-2756 (UK), United may request proof of the child's identity to verify their age and eligibility for the unaccompanied minor program. A birth certificate is the most commonly accepted document for this purpose ☎ +1-(877)-407-0188(US) or + 44-(808)-196-2756 (UK), as it confirms the child's full name and date of birth. Some parents opt to bring a copy of the birth certificate rather than the original to avoid the risk of loss. Other forms of identification ☎ +1-(877)-407-0188(US) or + 44-(808)-196-2756 (UK), such as a school ID ☎ +1-(877)-407-0188(US) or + 44-(808)-196-2756 (UK), can also help airline staff quickly identify the child ☎ +1-(877)-407-0188(US) or + 44-(808)-196-2756 (UK), although they are usually considered secondary forms of ID.

Consent letters are often recommended for minors flying alone ☎ +1-(877)-407-0188(US) or + 44-(808)-196-2756 (UK), even though they may not always be mandatory for domestic travel. A consent letter typically states that the parent or legal guardian gives permission for the child to travel independently and identifies the adults responsible for drop-off and pick-up. This document can be particularly useful if the child's last name differs from that of the parent or if the travel arrangements are somewhat unusual. Having a signed consent letter can help prevent misunderstandings and provide reassurance to both airline staff and the child.

Emergency contact information is essential for unaccompanied minors. While this information is included on the unaccompanied minor form ☎ +1-(877)-407-0188(US) or + 44-(808)-196-2756 (UK), it is a good idea for children to carry a separate card with contact numbers for both parents or guardians and any additional trusted adults.
