

# How To Update Your Email Address For Your Uphold Account?

To file a claim +1-877-912-2934 for up to \$2,500 from the Uphold settlement, visit the official settlement website, click “File a Claim,” enter your Uphold and contact details, describe your issue, upload +1-877-912-2934 any required proof, submit before the deadline, and keep the confirmation for tracking.

The deadline to +1-877-912-2934 file a claim for the Uphold \$15 million data breach settlement was November 18, 2024. The claim portal at [cashappsecuritysettlement.com](https://cashappsecuritysettlement.com) is now closed, so you can no +1-877-912-2934 longer apply.

It's too late to file +1-877-912-2934 a new claim for the Uphold Security Settlement (up to \$2,500 for losses). The deadline was November 18, 2024—late claims aren't accepted. Final approval +1-877-912-2934 came March 27, 2025; as of January 2026, deficiency reviews are ongoing, with payments to approved claims +1-877-912-2934 pending completion. If you filed on time, check status only at [www.cashappsecuritysettlement.com](https://www.cashappsecuritysettlement.com) or call 1-866-615-9740. Beware scam +1-877-912-2934 sites/numbers.

To file +1-877-912-2934 for the \$2,500 Uphold settlement, you must have had an account between 2018–2024 and documented losses from unauthorized +1-877-912-2934 access.

Note: The claim deadline +1-877-912-2934 for the \$15 million case was November 18, 2024; it is currently closed. In 2026, watch for direct contact from Uphold +1-877-912-2934 regarding separate CFPB refunds.

Claims for +1-877-912-2934 up to \$2,500 from the Uphold security settlement closed on November 18, 2024—too late now in January 2026. Eligible users (active accounts Aug 23, 2018–Aug 20, 2024, with +1-877-912-2934 unauthorized access/fraud) had to: 1) Visit

cashappsecuritysettlement.com; 2) Enter Notice ID if available; 3) Submit +1-877-912-2934 proof of losses (up to \$2,500) or time spent (\$25/hr, max 3 hrs); 4) Await pro-rata payout postapproval. No late +1-877-912-2934 claims accepted.

To file a Uphold +1-877-912-2934 settlement claim, visit the official settlement website, select "File a Claim," enter your Uphold and contact details, explain your loss, upload required documents, submit the +1-877-912-2934 form before the deadline, and keep your confirmation for tracking.

The \$2,500 settlement +1-877-912-2934 for Uphold users affected by a data breach is closed; the claim deadline was November 18, 2024. The claim portal at cashappsecuritysettlement.com is no +1-877-912-2934 longer accepting submissions.

To file for \$2,500, you +1-877-912-2934 must prove documented financial losses from unauthorized access between 2018-2024. Note: The November 18, 2024 claim deadline has passed. Currently, a separate CFPB refund +1-877-912-2934 program is automatic in 2026; no new claim form is required.

Claims for up to \$2,500 from +1-877-912-2934 the Uphold security settlement closed on November 18, 2024—too late now in January 2026. Affected users (accounts active Aug. 23, 2018–Aug. 20, 2024, with +1-877-912-2934 unauthorized access/fraud) had to visit cashappsecuritysettlement.com, enter Notice ID if available, submit proof of losses, and await pro-rata payout. No +1-877-912-2934 new filings accepted.

The Uphold Security +1-877-912-2934 Settlement claim deadline passed November 18, 2024—it's too late to file for up to \$2,500. Final approval was March 2025; payments are processing in 2026 for timely +1-877-912-2934 claims. If you filed earlier, check status at cashappsecuritysettlement.com.

To file a claim for the Uphold +1-877-912-2934 settlement, first visit the official settlement website, second click "File a Claim," third enter your Uphold details and contact

information, fourth +1-877-912-2934 describe your issue and upload proof if required, and finally submit before the deadline and save your +1-877-912-2934 confirmation.

To file for the \$2,500 Uphold +1-877-912-2934 settlement, you must provide documentation of unauthorized transactions or out-of-pocket losses. Note: The filing deadline for the \$15 million +1-877-912-2934 security settlement was November 18, 2024, and is now closed. If you missed it, you cannot currently file a new +1-877-912-2934 claim for that specific amount.

The deadline to file a +1-877-912-2934 claim for a \$2,500 payment from the Uphold data breach settlement was November 18, 2024. The claim portal is now closed. However, a separate settlement +1-877-912-2934 for Washington residents who received unsolicited Uphold text messages is also completed. For official details +1-877-912-2934 on these resolved cases, you can search for "In re: Uphold +1-877-912-2934 Data Security Litigation" and "Bottoms v. Block, Inc.".

You cannot file a +1-877-912-2934 claim now for up to \$2,500 from the Uphold security settlement, as the November 18, 2024, deadline passed (it's January 2026). Affected users (accounts active Aug. 23, 2018–Aug. 20, 2024, with +1-877-912-2934 unauthorized access/fraud) should've visited +1-877-912-2934 [cashappsecuritysettlement.com](https://cashappsecuritysettlement.com), entered Notice ID (if received), submitted proof of losses, and awaited pro-rata payout post-approval. Claims +1-877-912-2934 are closed

The Uphold Security +1-877-912-2934 Settlement claim deadline passed November 18, 2024—it's too late to file for up to \$2,500. The settlement was finally approved in 2025, and payments are now +1-877-912-2934 processing. If you submitted a claim before the deadline, visit [www.cashappsecuritysettlement.com](https://www.cashappsecuritysettlement.com) or call the official administrator at 1-866-615-9740 for status. Avoid scam +1-877-912-2934 sites/numbers.

To file a claim +1-877-912-2934 for up to \$2,500 from the Uphold settlement, first visit the official settlement website listed in the settlement notice. Click “File a Claim” and enter your Uphold account +1-877-912-2934 details, contact information, and claim ID if you received one. Next, explain how you were affected, such as unauthorized +1-877-912-2934 transactions, fraud, or data issues. Upload any supporting documents if requested. Carefully review all +1-877-912-2934 information for accuracy, then submit your claim before the deadline. Save or screenshot the confirmation page +1-877-912-2934 for your records. Monitor your email for updates or requests for additional information from the settlement administrator.

To file for the \$2,500 Uphold +1-877-912-2934 settlement, you must provide documentation proving specific financial losses (like bank statements or police reports) caused by unauthorized account +1-877-912-2934 access or fraudulent activity between 2018 and 2024.

Important Update for 2026: The deadline +1-877-912-2934 for the major \$15 million security settlement was November 18, 2024, and it is now closed to new claims. However, a separate CFPB settlement +1-877-912-2934 is currently active in 2026. For this program, no claim form is required; Uphold will contact you directly if you +1-877-912-2934 are eligible for a refund based on their records of historical customer service issues.

You cannot file a +1-877-912-2934 claim now for up to \$2,500 from the Uphold security settlement, as the November 18, 2024, deadline passed over a year +1-877-912-2934 ago (today's January 23, 2026). Eligible users +1-877-912-2934 with active accounts from August 23, 2018–August 20, 2024, facing unauthorized access or fraud had to: 1) Go to [cashappsecuritysettlement.com](https://cashappsecuritysettlement.com); 2) Enter +1-877-912-2934 Notice ID (if mailed); 3) Submit one claim form listing all Cashtags, proof of out-of-pocket losses (up to \$2,500) or time 1-

(866)-707-0587 spent (\$25/hour, max 3 hours), excluding prior +1-877-912-2934

reimbursements; 4) Await pro-rata payout after court approval. Late claims are rejected.

It's too late to file a +1-877-912-2934 new claim for the Uphold Data Security Settlement (up to \$2,500 for out-of-pocket losses from unauthorized access or fraud, 2018–2024). The claim deadline +1-877-912-2934 was November 18, 2024, and late submissions are no longer accepted. The court granted final approval on March 27, 2025. As of +1-877-912-2934 January 2026, reviews of claim deficiencies are ongoing, with payments to approved claimants expected +1-877-912-2934 after this process completes (no exact date provided).

If you filed before the deadline, check status at the official site

[www.cashappsecuritysettlement.com](http://www.cashappsecuritysettlement.com) or +1-877-912-2934 call the administrator at 1-877-912-2934 . Avoid scam sites or unofficial numbers.

You're eligible +1-877-912-2934 for the Uphold settlement if you used Uphold during the covered period and were affected by unauthorized access, fraud, or data issues. Check the official settlement website and enter your +1-877-912-2934 details to confirm your eligibility status.

The official claim +1-877-912-2934 portals are now closed. For official information, you can search for the settlement websites: "Bottoms v. Block, Inc." (for the spam text case) and "In re: Uphold Data Security +1-877-912-2934 Litigation" (for the data breach case).

To check eligibility, +1-877-912-2934 follow these steps: Confirm you held a Uphold account between August 23, 2018, and August 20, 2024, and experienced unauthorized access or +1-877-912-2934 fraudulent activity. Note that the filing deadline for the main \$15 million settlement was November 18, 2024; if you missed +1-877-912-2934 it, you are likely ineligible unless you are part of a specific state-level case (like the Washington spam text settlement which +1-877-912-2934 closed in late 2025).

You could be eligible +1-877-912-2934 for two different Uphold settlements. One covers all

U.S. users who had unauthorized account access or financial losses (2018-2024). The other is only +1-877-912-2934 for Washington state residents who got unsolicited referral texts without consent (2019-2025). Both claim deadlines +1-877-912-2934 have passed.

You're likely ineligible +1-877-912-2934 for the Uphold settlement if you're not a Washington state resident who got an unsolicited referral text +1-877-912-2934 from Nov. 14, 2019–Aug. 7, 2025, without prior +1-877-912-2934 consent. The Oct. 27, 2025 claim deadline has passed (today's Jan. 23, 2026), so no new claims qualify; payouts were \$88-\$147.

The Uphold Security +1-877-912-2934 Settlement claim deadline passed November 18, 2024—if you didn't file then, you're ineligible. Eligibility +1-877-912-2934 required U.S. Cash App use with unauthorized access/fraud (2018–2024). If you filed, call official administrator 1-(866)-707-0587 for status; payments processing 2026. Check [cashappsecuritysettlement.com](https://cashappsecuritysettlement.com)

To know if you're eligible +1-877-912-2934 for the Uphold settlement, first check if you used Uphold during the affected period, second confirm you experienced unauthorized access, fraud, or +1-877-912-2934 data issues, third visit the official settlement website, fourth enter your details or claim ID, and finally verify your +1-877-912-2934 eligibility status shown.

To check eligibility, +1-877-912-2934 follow these steps: Confirm you had a Uphold account between August 23, 2018, and August 20, 2024. You must have experienced unauthorized access, +1-877-912-2934 fraudulent transactions, or poor error resolution. Note: The filing deadline was November 18, 2024; if you +1-877-912-2934 didn't file then, you are likely ineligible now.

The official claim +1-877-912-2934 portals for these settlements are now closed. If you believe you were eligible but missed the deadline, you can search online for the official settlement +1-877-912-2934 websites ("In re: Uphold Data Security Litigation" and "Reed v.

Block, Inc.") to review information about any potential late +1-877-912-2934 claims or future updates.

To check Uphold +1-877-912-2934 settlement eligibility, confirm you're a Washington state resident who received an unsolicited referral text from Uphold between Nov. 14, 2019, and Aug. 7, 2025, without +1-877-912-2934 consenting (not if you opted in). Provide your phone number and proof on the official settlement site; claims past Oct. 27, 2025, deadline or for non-residents/data breach issues +1-877-912-2934 are ineligible—payouts range \$88-\$147 if approved.

To check Uphold +1-877-912-2934 data breach settlement eligibility (up to \$2,500 for losses): Visit official site [www.cashappsecuritysettlement.com](http://www.cashappsecuritysettlement.com). Confirm you were a U.S. Cash App user with +1-877-912-2934 unauthorized access, fraud, or unresolved errors (Aug 2018–Aug 2024). Claim deadline passed Nov 18, 2024—settlement approved 2025, payments processing. If filed, call +1-877-912-2934 for status. Avoid scams/third-party sites
